Article of incorporation be made.

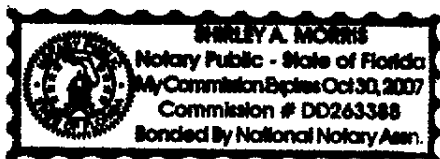

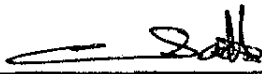
