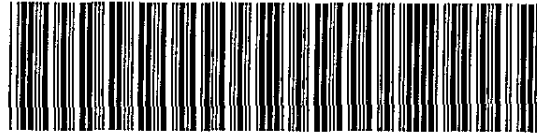





6. The initial Board of Directors shall have 2 members whose name's and address are as follows:


