#### ARTICLES OF INCORPORATION

OF

#### PALMMARK INVESTMENTS, CO.



#### ARTICLE I NAME

The name of the corporation is PALMMARK INVESTMENTS, CO.. The address of the Corporation is 8402 Pine Thrust Way, Tampa, Florida 33647.

#### ARTICLE II DURATION

The Corporation shall have perpetual existence.

## ARTICLE III PURPOSE
