

ARTICLES OF INCORPORATION

OF

DOLPHIN CONCRETE & CURB, INC.



I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I Name and Principal Address

The name and principal address of the corporation shall be: DOLPHIN CONCRETE & CURB, INC., 4400 Marsh Landing Boulevard, Suite 1, Ponte Vedra Beach, Florida 32082. The mailing address shall be the same.

ARTICLE II Duration

This corporation shall have perpetual existence.
