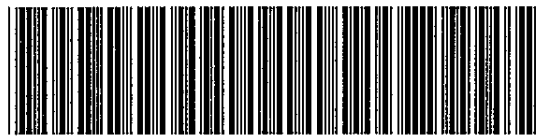

ARTICLES OF INCORPORATION  
OF  
THE BARCODE PARTS DEPOT, INC.

In compliance with Chapter 607 and/or 621, F.S. (Profit)

ARTICLE I - NAME

The name of this corporation shall be **THE BARCODE PARTS DEPOT, INC.**

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of this corporation is as follows: 2330 Success Dr. Suite A, Odessa, FL 33556 and the mailing address of this corporation is the same.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares of capital stock that the corporation is authorized to issue is Seven Thousand Five Hundred (7,500) shares of common stock with a par value of One (\$1.00) Dollar per share.

ARTICLE X - INFORMAL ACTIONS OF DIRECTORS

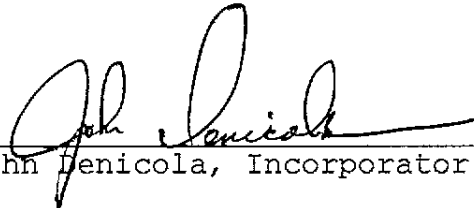

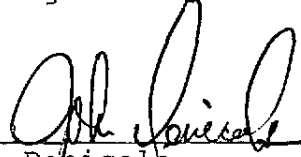
