STATE OF FLORIDA ARTICLES OF INCORPORATION

OF

THE GRAPHIC GUY, INC.

FIRST The name of this corporation is The Graphic Guy, Inc.

SECOND. Its registered office in the State Of Florida is to be located at 10310 Soaring Eagle Drive, Riverview, Florida 33569, County of Hillsborough. The registered agent in charge thereof is Kenneth G. Hanson, 10310 Soaring Eagle Drive, Riverview, Florida 33569.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted, and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.

SEVENTII. The Directors shall have the power to make and to alter or amend the By-Laws; to fix the amount to be reserved as working capital, and to authorize and cause to be executed mortgages and liens without limit as to the amount, upon the property and franchise of the Corporation.

With the consent in writing, and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding, the Directors shall have the authority to dispose, in any manner, of the whole property of the corporation.
