

ARTICLES OF INCORPORATION OF TURNER INSURANCE CONSULTING, INC. 04 MAR -9 PM 4: 07

Pursuant to Chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I (Name)

The name of the Corporation ("Corporation") is Turner Insurance Consulting, Inc.

ARTICLE II (Principal Office)

The street address and mailing address of the initial principal office of the Corporation is 180 Magnolia Court, Havana, Florida 32333.

ARTICLE III (Purpose)

The general purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE IV (Shares)

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$.01 per share, all of which shall be Common Shares. Such shares shall be of a single class. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one.
