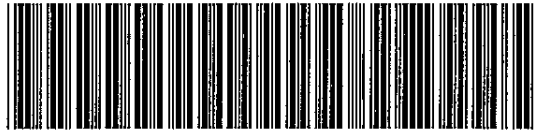

ARTICLE ONE
NAME

DURATION
