### ARTICLES OF INCORPORATION ART CLEMENT HANDYMAN LAWN & YARD CARE

ALLAMISSEE FLORING The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

#### ARTICLE I

SERIES: The Corporation is not authorized to issue shares in series.

#### Board of Directors

#### Shareholder Action

Three-fourth's (3/4th's) of the Stockholder(s) of the Corporation shall be required for any shareholder action.

#### Power to Adopt, Amend, Alter, Change or Repel Articles
