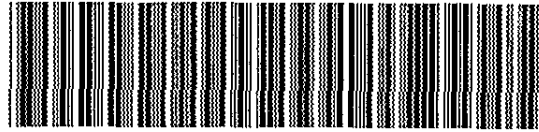



**ARTICLES OF INCORPORATION
OF
FRIEDLINE AND McCONNELL, P.A.**

The undersigned Subscriber, a natural person competent to contract, desires to form a Professional Service Corporation under the laws of the State of Florida for the purpose of engaging in the practice of law, all of whose Stockholders shall consist of persons or Professional Corporations duly licensed to practice law in the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is **FRIEDLINE AND McCONNELL, P.A.** and the principal office and address is: **1756 University Boulevard, Jacksonville, FL, 32216.**

ARTICLE II. NATURE OF BUSINESS

This Corporation is organized for the following purposes:

A. To engage in the practice of law as a Professional Law Corporation and carry on services incidental thereto. The practice of law is the sole and exclusive professional service to be rendered by this Corporation.

B. To own property, both real and personal and mixed, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this Corporation.

C. The professional services of this Corporation shall be carried out only through Officers, employees, and agents, each of whom has been admitted to the Bar of, and is duly authorized to practice law in the State of Florida.

ARTICLE III. CAPITAL STOCK

The total number of shares of stock which the Corporation shall have authority to issue is Five Thousand (5,000) all of one class, namely common stock, and the par value

of each such share is One (\$1.00) Dollar amounting in the aggregate to Five Thousand (\$5,000.00) Dollars. The capital stock shall be issued only to individuals or Professional Corporations who are duly licensed to practice law in the State of Florida, or otherwise legally authorized in the State of Florida to render the same specific professional services as those for which the Corporation was incorporated.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this Corporation shall commence business is One Thousand Dollars (\$1,000.00).

ARTICLE V. TERM OF EXISTENCE

The Corporation shall begin its existence on the date these Articles of Incorporation are subscribed and acknowledged, and the duration of the Corporation thereafter shall be perpetual, unless sooner terminated in accordance with law.

ARTICLE VI. REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 1756 University Boulevard South, Jacksonville, Duval County, Florida, 32216, and the name of its initial Resident Agent at such address is **RODGER J. FRIEDLINE**.

ARTICLE VII. DIRECTORS

This Corporation shall have two (2) Directors initially. The number of Directors may be changed from time to time by the By-laws as adopted by the Stockholders.
