ARTICLES OF INCORPORATION OF

FRIEDLINE AND McCONNELL, P.A.

The undersigned Subscriber, a natural person competent to contract, desires to form a Professional Service Corporation under the laws of the State of Florida for the purpose of engaging in the practice of law, all of whose Stockholders shall consist of persons or Professional Corporations duly licensed to practice law in the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is **FRIEDLINE AND McCONNELL**, **P.A.** and the principal office and address is: **1756 University Boulevard**, **Jacksonville**, **FL**, **32216**.

ARTICLE II. NATURE OF BUSINESS

This Corporation is organized for the following purposes:

- A. To engage in the practice of law as a Professional Law Corporation and carry on services incidental thereto. The practice of law is the sole and exclusive professional service to be rendered by this Corporation.
