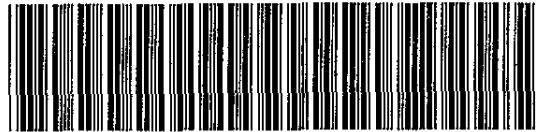

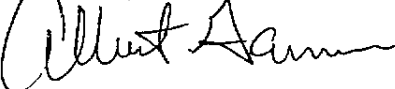

## ARTICLES OF INCORPORATION

### ARTICLE I. CORPORATION NAME

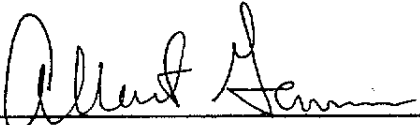

ARTICLE IX. AMENDMENT

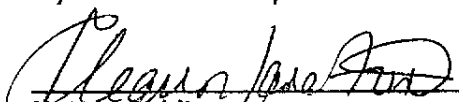
