**ARTICLES OF INCORPORATION
OF
KINSEY ENTERPRISES, INC.**

ARTICLE I: NAME

The name of the corporation shall be: **KINSEY ENTERPRISES, INC.**

The address of the principal office and mailing address of this corporation shall be:

951 NW 3rd Avenue

Florida City, FL 33030

And the mailing address of corporation shall be the same.

ARTICLE II: NATURE OF THE BUSINESS

The purposes and general nature of the business to be conducted and transacted by the corporation shall be to do and transact any and all business as permitted under the laws of the State of Florida and the United States of America. Without limiting any of the purposes, powers and objects of this corporation, it is expressly declared and provided that this corporation shall have power in carrying on its own business, or for the purpose of accomplishment of any of the purposes or attainment of the objects herein above specified to make and perform contracts of any kind and description and to do any and all other acts and things and to exercise any and all powers, either as principal, agent or broker, conferred by the Laws of Florida upon corporations and which a partnership or natural person could do and exercise, and which now or hereinafter may be authorized by law.

ARTICLE III: CAPITAL STOCK

The corporation is authorized to issue a maximum of one thousand (1,000) shares of common stock having a par value of one dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

ARTICLE IV: REGISTERED AGENT

The street address of the initial registered office of the corporation shall be 951 NW 3rd Avenue, Florida City FL 33030, and the name of initial registered agent of the corporation at that address is Herbert Fabio.

ARTICLE V: TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI: DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation. All rights of shareholders are subject to this reservation.

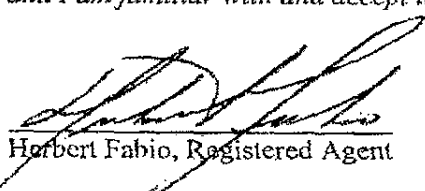
