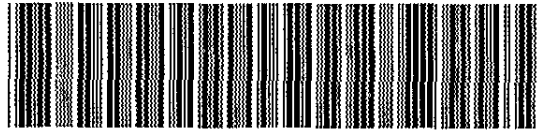

ARTICLE VI - INITIAL PRINCIPAL OFFICE AND AGENT

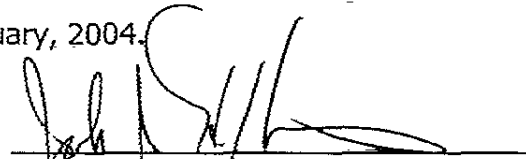

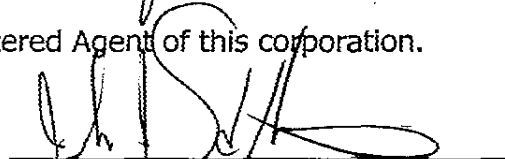
