ARTICLES OF INCORPORATION OF

Manna Marketing, Inc.

ARTICLE 1. - NAME

The name of the Corporation is Manna Marketing, Inc..

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the Corporation shall initially be at 2174 Schwalbe Way, Sarasota, Florida 34235-8143. The Corporation may change its principal office from time to time as permitted by law.
