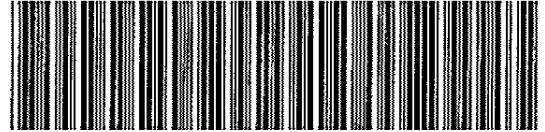

**ARTICLE II - DISSOLUTION AUTHORIZED**


Dissolution of the Corporation was authorized on June 30, 2005.


