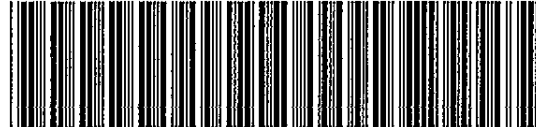

The purpose for which the Corporation is organized is to engage in any and all lawful business for which corporation may be incorporated under Chapter 607, Florida Statute, as amended.

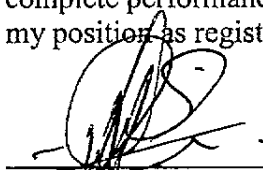
