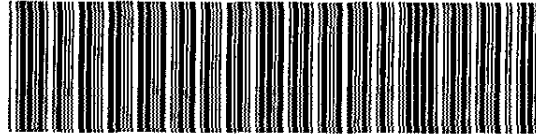

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit), the undersigned, acting as the incorporator of a corporation under the laws of the State of Florida, submits the following Articles of Incorporation for such corporation.

ARTICLE I

*Name and Style of Corporation*

The name and style of the proposed corporation is

"Greenworks Plus, Inc."

ARTICLE II

*Principal Office*

ARTICLE III

*Duration of Corporation*

The period of existence of this Corporation shall be perpetual.

ARTICLE IV

*Specific Purpose of Corporation*

The purpose or purposes for which the corporation is organized are:

- (a) To own and operate a lawn care and general maintenance business for the purpose of providing lawn care services and general maintenance and repair services;
- (b) To engage in the business of providing lawn care services and general maintenance and repair services, including and not limited to, operation and maintenance of equipment necessary and useful in this business, with right to maintain equipment on public or private

property and to use real and personal property of all kinds for the operation of business.

- (c) To purchase, lease or otherwise acquire such supplies, materials and other articles as necessary to conduct business; and to have any and all powers necessary to carry out the purposes above set forth;
- (d) To engage in the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607 and/or 621 F.S.
- (e) To hire and employ others as necessary to conduct business;
- (f) To enter into contracts or arrangements of any kind or character that this corporation is empowered to do;
- (g) To borrow money and to give as security any property, real, personal or mixed, owned by this corporation;
- (h) To exercise such powers and rights as are conferred on corporations under the provisions of the statutes or laws of the State of Florida;

The foregoing statement of purposes shall be construed as a statement of both purposes and powers of this corporation and the powers and purposes stated in each clause shall not be construed to limit in any manner the general powers, but are in furtherance of, and in addition, and not in limitation of said general purposes.

##### *Aggregate Number of Shares*

The aggregate number of shares which the Corporation shall have the authority to issue is One Hundred (100) shares of common stock of the par value of Ten and 00/100 (\$10.00) Dollars each and the Corporation shall begin business with One Thousand and 00/100 (\$1,000.00) Dollars Capital Stock.

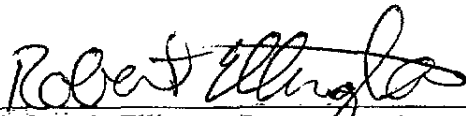
