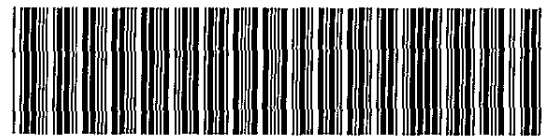

ARTICLES OF INCORPORATION
OF

ARIO, INC.

Article I - Name

The name of the corporation is ARIO, INC., and the principal office and mailing address is 1488 Gulf to Bay Boulevard, Clearwater, Florida 33755.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

This corporation is organized for the following purpose: the general purpose for which this corporation shall be organized shall include the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.


