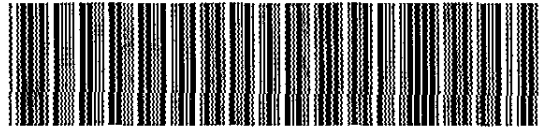

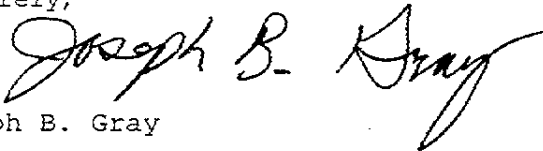

ARTICLE I - NAME

ARTICLE II - NATURE OF BUSINESS

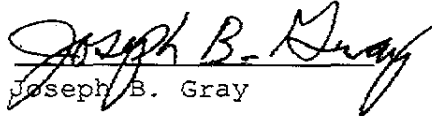

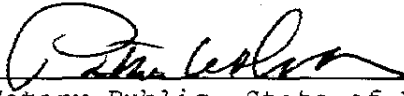

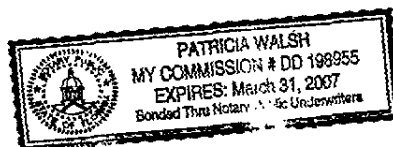
