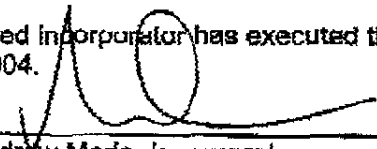
#### ARTICLE XI - I.R.C. STOCK PROVISION
