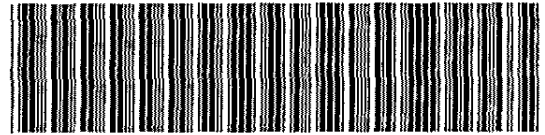

Article I, Name, will be amended to read:

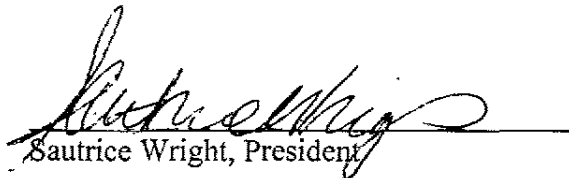
The name of the corporation shall be: SULI CORP
