

WE THE UNDERSIGNED, hereby associated ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

## ARTICLE I

The name of this corporation shall be DON RAMEY ASSOCIATES, INC.

## ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted providing consulting services to individuals and business entities. The corporation may also engage in any activity or business permitted under the laws of the United States and the State of Florida, including the purchasing and selling of any real estate or personal property, or contracts for the same, and to have, and to exercise such general corporate powers as is now or may hereafter be given corporations organized under Florida Statutes 607 and amendments thereto.

#### ARTICLE III CAPITAL STOCK
