FIRST: The name of this corporation is ROCHE ENVIRONMENTAL, INC.

SECOND: The general nature of the business to be transacted by this corporation, together with and in addition to those powers conferred by the laws of Florida and the United States of American and the principles of common law upon corporations organized under and by virtue of the laws of Florida and the United States of American and the principles of common law upon corporations organized under and by virtue of the laws of Florida is the following, viz:

To engage in lawn maintenance, landscaping and the sale of plants, ground cover and other landscaping materials and supplies.

To take, own, hold, deal in, mortgage or otherwise give lien against, and to lease, exchange, transfer or in any manner whatever, to dispose of real property within or without the State of Florida, wherever situated; To purchase or otherwise acquire in any lawful manner and to hold, own, mortgage, pledge or otherwise to give liens against, lease, sell, assign, transfer, or in any manner dispose of, deal in and trade with and invest in goods, wares and merchandise and property of any kind and class, both within the State of Florida and without said State.
