ARTICLES OF INCORPORATION OF
PRISM TAG AND LABEL INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation.

ARTICLE ONE

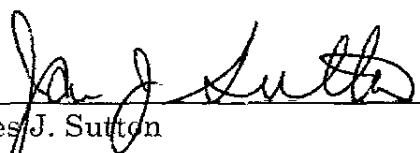

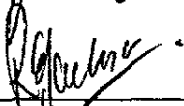
