**ARTICLES OF INCORPORATION
OF
STREETS OF GOLD DECK TOPPING, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: STREETS OF GOLD DECK TOPPING, INC.


