ARTICLE V. OFFICE AND ADDRESS OF REGISTER AGENT.

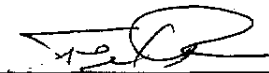

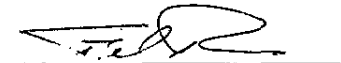
