ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. The name of the corporation is TRIPLE A ENTERPRISE OF SOUTHWEST FLORIDA, INC.
2. The address of the corporation is 120 Rose Blvd., Naples, FL 34119.
3. The period of its duration is perpetual.
4. The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.
5. The corporation shall have authority to issue seventy-five hundred shares, all of one class, one dollar par value.
6. The name of its initial registered agent is Christian B. Felden and the address of its initial registered office is Orion Bank, 3838 Tamiami Trail North, Suite 416, Naples, Florida 34103.
7. The initial Board of Directors shall consist of one (1) member, who need not be a resident of the State of Florida or shareholder of the corporation.
8. The names and addresses of the person who shall serve as director until the first annual meeting of shareholders, or until his successor shall have been elected and qualified, is Judson R. Alford, 120 Rose Blvd., Naples, FL 34119.
9. The names and address of the initial incorporator is Judson R. Alford, 120 Rose Blvd., Naples, FL 34119.
10. The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholder's meeting, with not less than a majority vote of the common stock.
11. The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions as shall be fixed by the Board of Directors, such of

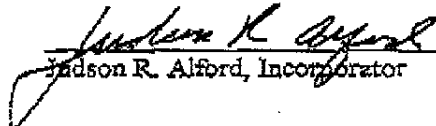

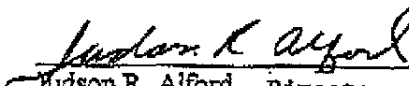

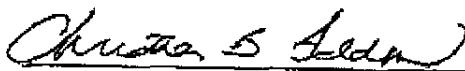
