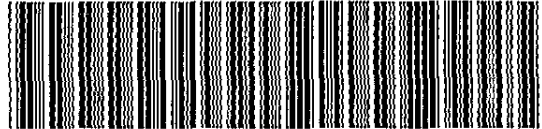

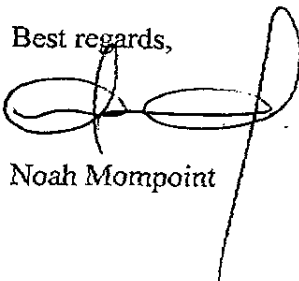

Article III - Purpose

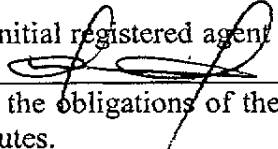
