ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:**

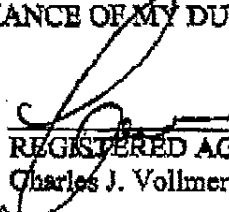
