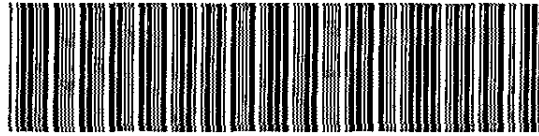

**I, THE UNDERSIGNED**, desiring to form a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges, and immunities of corporations for profit, DO HEREBY CERTIFY AS FOLLOWS:

#### **ARTICLE – I – NAME OF CORPORATION**

The name of the corporation shall be **GET HOME NOW SERVICES, INC.**

#### **ARTICLE – II – PRINCIPAL PLACE OF BUSINESS**

The principal place of business of this corporation and the street address of its corporate office shall be at 2006 NE 49<sup>th</sup> Street, Ft. Lauderdale, Florida 33308 with the privilege of transferring locations or having branch offices at other places within or without the State of Florida, and within or without the United States of America.
