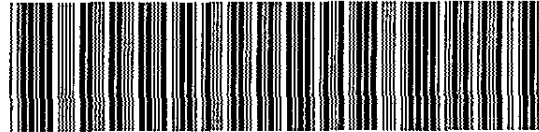

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME


ARTICLE XI - INCORPORATOR
