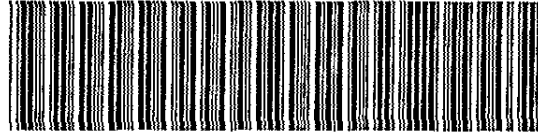



OF

ARTICLE I

The name of this corporation is **FISHER'S CUSTOM CABINETS, INC.**

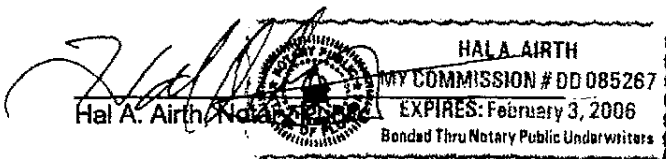
