ARTICLE I: NAME

The name of this corporation shall be Jan & Jeff Enterprises, Inc.

ARTICLE II: DURATION

The corporation shall have a perpetual existence.

ARTICLE III: PURPOSE

The purpose of this corporation is to engage in any activity or business permitted by the laws of the State of Florida or the United States of America.

ARTICLE IV: STOCK
