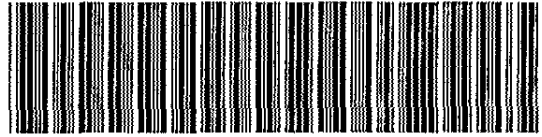

The name of this corporation is MIDERECO, INC. and the mailing address of the corporation shall be 7800 University Pointe Drive, Suite 200, Fort Myers, FL 33907.

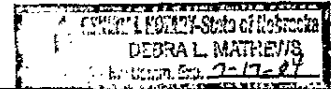
