

**ARTICLE OF INCORPORATION  
OF

**ARTICLE ONE**

The name of the corporation is A.G.H.A. COMMUNICATIONS, INC. The principal address of the corporation is: 11471 West Sample Road, Suite 30, Coral Springs, Florida 33065.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of no par value.


**ARTICLE FIVE**
