The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

## ARTICLE I CORPORATE NAME

The name of the corporation shall be Gary Lupone, Inc. And the corporations' principal address shall be 8855 Springtree Lake Dr, Sunrise, Fl. 33351.

#### ARTICLE II TERMS OF EXISTENCE

This corporation shall have perpetual existence.

## ARTICLE III NATURE OF BUSINESS AND POWERS
