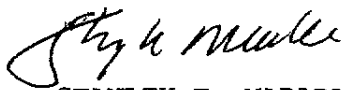

CERTIFICATE OF INCORPORATION

OF

ARTICLE I

The name of this corporation shall be:

TWO SISTERS CLEANING SERVICES, INC.

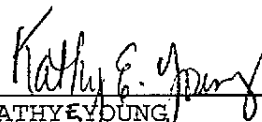

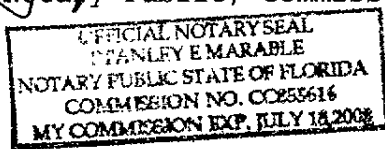

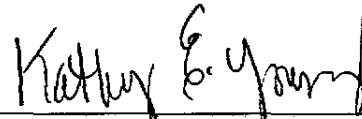
