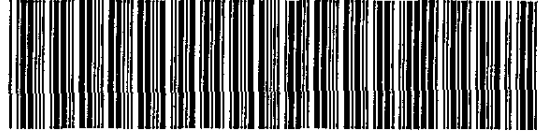

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of incorporation. TALLAHASSEE, FLORIDA

ARTICLE I- NAME AND ADDRESS

The name of the Corporation is: STRESS FREE CORPORATE HOUSING, INC.
The principal office address is: 1851 NW 125th Avenue, Pembroke Pines, FL 33028.

ARTICLE II- DURATION

The duration of the Corporation is perpetual

ARTICLE III- PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporations Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. Provide housing and all matters related thereto.

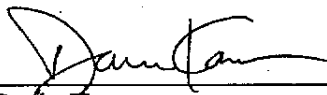
