#### ARTICLE I. NAME

The name of this corporation shall be Malleus, Inc.

#### ARTICLE II. COMMENCEMENT & DURATION

The commencement of the corporation's existence shall be at the time of filing of these Articles of Incorporation by the Department of State. This corporation's duration shall be perpetual.

#### ARTICLE III. PURPOSE

This corporation is being organized for the purpose of conduction any and all lawful business activities permitted under the laws of the State of Florida and the United States of America.

#### ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 100 par shares of common capital stock, out of a total of 1,000 shares, at \$1.00 per share par value.

#### ARTICLE VI. TRANSFER RESTRICTIONS
