ARTICLES OF INCORPORATION OF G & J AUTO BODY INC

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, to hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the corporation is G & J Auto Body Inc

ARTICLE TWO CORPORATE DURATION
