Articles of Incorporation
of

ARTICLE I – NAME

The name of this corporation is **T. K. Hart Painting, Inc.**

ARTICLE II – DURATION

This corporation is to have perpetual existence.

ARTICLE III – INDEMNIFICATION

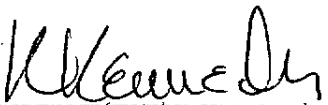
The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

ARTICLE XIV – AMENDMENT

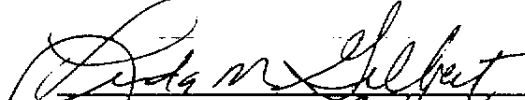

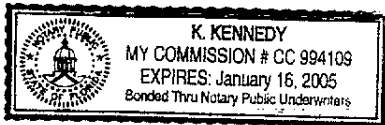
