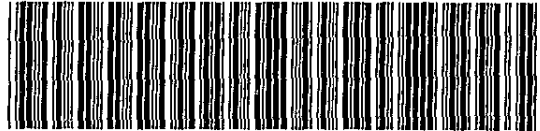

**ARTICLES OF INCORPORATION
OF
COMMERCIAL PAINTING & CAULKING, CO.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be COMMERCIAL PAINTING & CAULKING, CO.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

To provide commercial painting and reconstruction work, and to engage in any lawful act or activity for which the State of Florida permits.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred (100) shares of Ten Dollar (\$10.00) par value . Romulo H. Gernandizo shall own 49% of the stock and Laura Gernandizo shall own 51% of the stock.

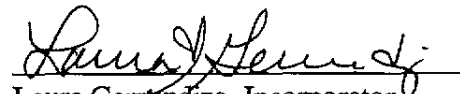
ARTICLE X - INDEMNIFICATION
