



ARTICLES OF INCORPORATION

OF

DAVID A. FEFFER, P.A.


- ARTICLE I.** The name of this corporation is David A. Feffer, P.A., operating at 9900 W. Sample Rd., Suite 300, Coral Springs, FL 33065
- ARTICLE II.** This corporation shall have perpetual existence, unless sooner dissolved according to law.
- ARTICLE III.** This corporation is organized for the following purpose: Any lawful purpose.
- ARTICLE IV.** This corporation is authorized to issue One Thousand (1000) shares of common stock having a par value of \$1.00 per share.
- ARTICLE V.** The street address of the initial registered office of this corporation is: 9900 W. Sample Rd., Suite 300, Coral Springs, FL 33065, and the name of the initial registered agent of this corporation at that address is David A. Feffer.
- ARTICLE VI.** This corporation shall have 1 Director initially. The number of directors may be increased or diminished from time to time by By-Laws, but shall never be less than one. The name and address of the initial director of this corporation is:


