Wave Communications, Group, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be Wave Communications Group, Inc. whose principal office and mailing address is 112 Barefoot Cove Road, Hypoluxo, Florida 33462.

This corporation shall have perpetual existence.


