ARTICLES OF INCORPORATION

FIRST: The name of the corporation (the "Corporation") is:

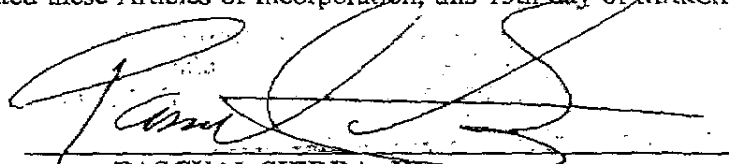

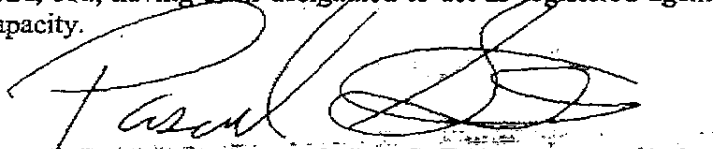
