ARTICLES OF INCORPORATION OF

T & J OF PONCE INLET, INC.



The undersigned, acting as incorporator of a corporation, hereby adopts the following Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is **T & J OF PONCE INLET, INC.** and the mailing address is **70 Rains Court, Ponce Inlet, Florida 32127** and the principal office address is **2800 Nova Road, South Daytona, Florida 32119**.
