## ARTICLE I - NAME

The name of this Corporation is: JOSE ROMO CONSTRUCTION INC..

#### ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence existence on the date of filing of these Articles of Incorporation.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the Laws of the United States of America, and the Laws of the State of Florida, and specifically dealing in Drywall.

#### ARTICLE IV ~ CAPITAL STOCK

This Corporation is authorized to issue 10000 shares of common stock at Ten (10) Cents par value. Shares may be issued for such consideration as is determined from time to time by the shareholders. This Power is reserved unto the shareholders by right and is hereby delegated unto the Board of Directors. The Board may issue the shares of this Corporation for such consideration as is determined from time.
