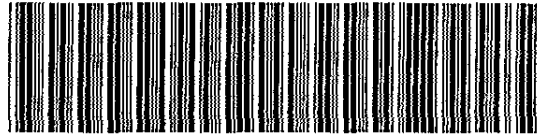

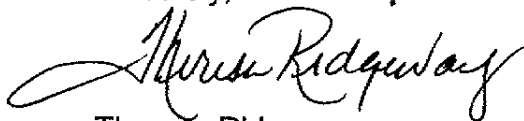

The name of this Corporation is RGF PROPERTIES, INC., and the principal business and mailing address of the Corporation is 2120 University Blvd., Jacksonville, Florida 32217.

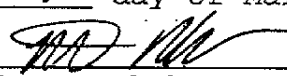

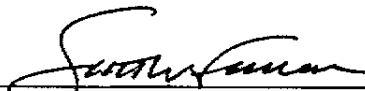
