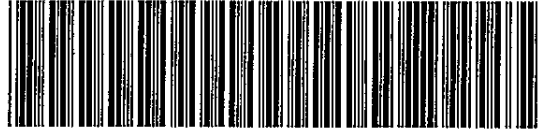



ARTICLE FOUR: This corporation shall have perpetual existence as provided for by Florida law.




